## The Importance of Collecting Social Determinants of Health

Social Determinants of Health (SDOH) fall under "Healthy People 2030."

Healthy People 2030, a decade-long initiative developed through the Department of Health and Human Services (HHS), is data-driven national objectives to improve health and well-being over the next decade.

In a recent statement from both the Joint Commission and CMS, "by incorporating SDOH into their accreditation standards and value-based care programs, this will likely lead to improved patient health and reduced health disparities over time." HINT: You can expect this to become a Star measure for the collection of HEDIS! Do not be caught with a blank on your patients' records. Be sure to question your patients' status on their current SDOH. Life happens quickly, and circumstances change with the beat of a heart!

Social Determinants of Health are the conditions in the environment where people are born, live, learn, work, play, worship, and age that affect a wide range of health, functioning, and quality-of-life outcomes and risks. The World Health Organization (WHO) estimates that SDOH accounts for 30-55% of health outcomes.

## **Z** Codes are Key

It has been shown that the capturing of Z codes can potentially reduce hospitalizations and unnecessary ER visits by screening for social needs and connecting them to care managers and community health workers. SDOH can be collected through person-provider interaction or be self-reported, as long as it is signed off on and incorporated into the medical record by the clinician or provider.

The Z codes that address factors influencing health status and contact with health services are Z00-Z99. The Z codes that are generally addressed during an office visit are Z55-Z65. These include housing, inadequate access to food, income instability, life stressors, and social environment.

## **Coding Tip Corner**

The ICD-10-CM Official Guidelines for Coding and Reporting on encounters for COVID-19 screening have been revised. Some important updates that became effective October 1, 2023:

- For encounters for COVID-19 screening on or after October 1, assign code Z11.52, Encounter for screening for COVID-19.
- For an encounter for COVID-19 screening that is performed as part of preoperative testing, assign code Z01.812, Encounter for preprocedural laboratory examination, as the first-listed diagnosis and code Z11.52, Encounter for screening for COVID-19, as an additional diagnosis.
