The Centers for Medicare and Medicaid Services (CMS) requires that all providers seeing beneficiaries enrolled in a Chronic Special Needs Plan (C-SNP), such as our Diabetes and Heart Care Plan (HMO C-SNP), participate **annually** in Model of Care (MOC) Training.




